TERMS AND CONDITIONS

1. Bed-on-a-Boat.com Giethoorn

1.1 The Bed-on-a-Boat.com is described in the website www.bed-on-a-boat.com. This website has been compiled with the utmost care, but there may be differences between the text and / or photos presented on the website and the current situation in the Bed-on-a-Boat.com at the time of the visit by the guest(s). No rights can be derived from such differences by the guests.

1.2 The minimum stay in Bed-on-a-Boat.com is one night. In the holiday periods and / or in the summer months a different minimum stay may apply.

1.3 The Bed-on-a-Boat.com is accessible 24 hours a day. The Bed-on-a-Boat.com area has their own lockable entrance.

1.4 Rest periods are from 23.00 - 07.00.

1.5 Refundable damage deposit - A damage deposit of € 75,- is required upon arrival. This deposit is fully refundable during check-out as long as there has been no damage to the property.

1.6 Toilet Do not throw any other toilet paper or other items into the toilet. We provide toilet paper. If the toilet becomes clogged, we will have to charge these costs: € 75,- for unclogging the toilet.

1.7 This is a non-smoking boathouse. When smoking is ascertained, we will charge € 75,- to your account as a compensation for cleaning the room. Smoking is allowed on the terrace outside.

1.8 Pets of guests are not allowed in / at the Bed-on-a-Boat.com.

1.9 The Bed-on-a-Boat.com is suitable for two persons, unless indicated otherwise at the time of the reservation. In the living room is a sofa bed, with enough space for two kids to sleep.

1.10 Only the persons checked in to the Bed-on-a-Boat.com can use our rooms and facilities. It is not permitted to have visitors or extra guests over without consulting the Bed-on-a-Boat.com first. Breaching this rule can result in an early end of your reservation. A refund cannot be demanded.

1.11 Check-in from 15:00-19:00, check-out 08:00-10:00.

1.12 Guests can park their car at a designated location. Parking is at your own risk.

1.13 Guests must follow the instructions of the administrator.

1.14 The administrators can deny guests access to Bed-on-a-Boat.com and / or refuse access to Bed-on-a-Boat.com with immediate effect in case of violation of the general terms and conditions and / or the rules of procedure or in case of improper behavior, without further notice and reasons and without refund of accommodation costs.

1.15 Guests of Bed-on-a-Boat.com must comply with the rules of procedure that are provided online when booking and that are also available for inspection at the Bed-on-a-Boat.com.

1.16 The Bed-on-a-Boat.com is registered with the Chamber of Commerce under number 05080793.

2.0 Rates

- 2.1 The rates include gas, water, electricity and heating. The rates include VAT and tourist tax.
- 2.2 The rates do not include costs of cancellation and / or travel insurance and / or other costs.
- 2.3. Rates of the Bed-on-a-Boat.com are always without obligation and are subject to interim changes.
- 2.4 All entries on the website of the Bed-on-a-Boat.com (www.bed-on-a-boat.com) are deemed to have been provided in good faith and are always subject to interim adjustments. The Bed-on-a-Boat.com is not subject to obvious errors on its website.

3.0 Reservation and Payment

- 3.1 Reservation is possible online through www.bed-on-a-boat.com or via www.booking.com.
- 3.2 The reservation through bed-on-a-boat.com is only final after confirmation and your payment of the agreed amount.

4.0 Cancellation

- 4.1 Cancellation of a reservation through bed-on-a-boat.com is only free of charge until 14 days before the arrival date.
- 4.2 Cancellation of a reservation through bed-on-a-boat.com when deposit already paid, after arrival or early departure during the stay, the entire stay (confirmed total travel sum) will be charged.
- 4.3 Cancellations can only be made in writing via the contact form on the website or by email via info@bed-on-a-boat.com.
- 4.5 The Bed-on-a-Boat.com always has the right to withdraw the reservation more than 2 days prior to the date of arrival without giving reasons. Paid advances are refunded to the main guest at no cost.

5.0 Damage and deposit

- 5.1 Bed-on-a-Boat.com ask for a deposit of € 75,- to be paid in cash upon arrival for damage or extra costs.
- 5.2 The guest must behave properly and use the Bed-on-a-Boat.com accommodation in accordance with the reasonable instructions for use provided by the Bed-on-a-Boat.com or the owner / manager.
- 5.3 The main guest is legally liable for the damage caused by him or his fellow guests to the Bed-on-a-Boat.com accommodation or the items present there in.
- 5.4 Damage or extra costs for unclogging the toilet, damage or disappearance of inventory or deliberately caused damage to the boat itself, a refrigerator not emptied, presence of pets, smoking in the room, furniture that has been moved, not collected bed linen or still washing dishes in the kitchen.
- 5.4 This deposit is fully refundable during check-out as long as there has been no damage to the property.

6.0 Complaints

6.1 The guest is always entitled to submit his grievances by means of a complaint to the Bed-on-a-Boat.com. The Bed-on-a-Boat.com must always handle a complaint adequately and expeditiously, so that the complaint is dealt with according to standards of reasonableness and fairness.

7.0 Force Majeure

7.1 In the event of force majeure, both permanent and temporary, the Bed-on-a-Boat.com is entitled to dissolve the agreement in whole or in part or to suspend it temporarily, without the guest being entitled to claim fulfillment and / or compensation. Force majeure includes but is not limited to: danger of war, war, uprising, molestation, strikes, diseases, boycott, disturbances in the energy circuit, in traffic or transport, government measures, scarcity of raw materials, natural disasters and furthermore all circumstances, extraordinary weather conditions death of one of the owners or immediate family members, including full or partial fulfillment of the agreement in reasonableness and fairness can not be demanded from the Bed-on-a-Boat.com.

8.0 Liability

8.1 The Bed-on-a-Boat.com can not be held liable for damage suffered by the guest or third parties as a result of the stay in the accommodation; the guest indemnifies the Bed-on-a-Boat.com against claims in this regard. The Bed-on-a-Boat.com is not liable for malfunctions in and around the accommodation such as breakdowns and breakdowns of electricity and water supplies and technical installations, construction work and / or roadworks not or unavoidably announced in the vicinity of the B & B Bed-on-a-Boat.com.

10 Final provision

10.1 Unless otherwise stipulated in rules of private international law, these terms and conditions are governed exclusively by Dutch law.

10.2 All disputes ensuing from the user agreement or these conditions shall in the first instance be settled by the competent court in the Netherlands, insofar as the rules of private international law do not provide otherwise.

10.3 None of the parties can transfer its rights and obligations to third parties insofar as nothing else has been determined in these terms and conditions.

10.4 If and in so far as any provision in the user agreement and the present conditions should prove void, the other conditions remain intact and the void article shall be deemed to have been converted in such a way that it is brought into line with the apparent intentions of the parties.

Terminology

- Guest: a person who has booked and stays with Bed-on-a-Boat.com is registered as such.
- Main guest: the person who has booked with the Bed-on-a-Boat.com. The lead guest must be over 18 years old and is responsible for his / her fellow guests.
- Administrator: the person who, as owner of the Bed-on-a-Boat.com, or on behalf of the owner of the Bed-on-a-Boat.com, manages the Bed-on-a-Boat.com.
- Third parties: any other legal entity that is not a guest, manager or owner.
- Reservation: a confirmation of the reservation request by Bed-on-a-Boat.com Giethoorn.
- Cancellation: Revocation or cancellation of the definitive reservation within the applicable term or no-show at the time of the reservation.
